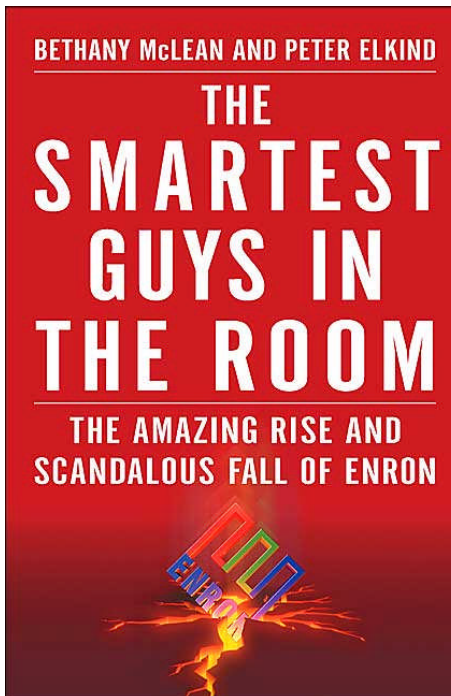
THE RISE AND FALL OF ENRON: WERE THEY REALLY THE SMARTEST GUYS IN THE ROOM?
